Learning Independence from Experience

The L.I.F.E. on the Coast program at Parents and Friends was started in 2008. It offers learning experiences that allow for greater independence for individuals. Whether we are living with family, roommates, or on our own, we all crave independence. For me, personally, independence means having the ability to make my own choices, and act on them accordingly. Sometimes I must enlist the help of others to help make my desires a reality and other times the plan involves just me.

To date, we have 23 individuals enrolled in the L.I.F.E. program. We oper-

ate Monday-Friday from 8:30-5:00 p.m. in order to serve the needs of our clients throughout the week. Upon entering the L.I.F.E. program, an individual meets with their circle of support and together design a customized plan that encompasses their unique goals and dreams. As an example, an individual's goals might include education, independent living skills, employment, self improvement, interpersonal relationships, hobbies, sports, volunteering and more.

Throughout the week, we learn from one another as well as from our peers in the community. Sometimes we want to

experience something new that may not exist in our community. As a result, we may design activities that help folks in the L.I.F.E. program meet their goals. In addition to what is offered in our community such as swimming, Zumba, and college-level courses, we have designed and offer a twice-weekly Craft & Science Lab, weekly Music & Dance groups, a weekly Anime Book Club, Ladies' Lunch, Coffee Talk Groups, as well as customized sessions that teach Money Matters as well as the importance of having Empathy toward others.

One of the things I myself have enjoyed so much in my first six months on the job is experiencing just how wonderfully supportive and inclusive our community is. From the local businesses that employ our work crews, offer donations, as well as opportunities to learn and give back to other local service organizations and non-profits that allow our groups to help them to give back and provide services.

Did you know that our clients not only work in the community, but also volunteer each week doing so many different things that make our coast a special place to live?

We even set the parameters of how to scientifically test whether a person meets those norms, and if not, what the prescribed remedy for this affliction will be — this affliction of not being more like us. The degree and severity of these remedies has changed over the years as our perception of normalcy has changed, but what has not changed is our insistence on creating this subset of society because of our own narcissistic obsession with conformity, even if that conformity tends to isolate and thereby punish and torment those we have identified as abnormal or disabled.

Kahlil Gibran wrote a parable in which there was a good, kindly King whose people were so happy and prosperous that the neighboring Kingdom became jealous. One night the jealous Kingdom snuck over and poisoned the good Kingdom's well. The next day everyone but the King drank from the well and went mad. The people rebelled against the good King and stormed the Castle until the King emerged and also drank from the well. They then lived happily ever after.

Where are we as a society on this time line now? We seem to be past the poisoning of the well. Perhaps all we need is for everyone to calm down and all have a cool drink from the well and stop being so judgmental of our peers and isolationist in our mediocrity that we call "normal".

Last week one client was very excited because they were arranging to go to Disney World in Florida this summer and another was looking forward to Camp. It was a fun discussion. The joy and enthusiasm was contagious.

Aldous Huxley said, "A child-like man is not a man whose development has been arrested; on the contrary, he is a man who has given himself a chance of continuing to develop long after most adults have muffled themselves in the cocoon of middle-aged habit and convention."

Kahlil Gibran, besides the parable I alluded to earlier, also said, "Keep me away from the wisdom which does not cry, the philosophy which does not laugh and the greatness which does not bow before children."
